JDI's Work


JDI is a health and human rights organization that seeks to end sexual violence in all forms of detention.



Why It Is Important

Transgender women:

- Face tremendous stigma and discrimination
- Experience disproportionate rates of violence, including sexual abuse, in and out of custody
- Are murdered at higher rates because of their gender, particularly trans women of color



Discrimination to Prison Pipeline

- Job and education discrimination
- Housing discrimination
- Lack of family and community support
- Lack of antidiscriminatory protection





Discrimination to Prison Pipeline



- Unequal access to opportunities and resources
- Participation in underground economies to survive
- Experience pervasive abuse and violence
- Recidivism



Characteristics of Detention

- Transgender women are often in facilities for men
- Hyper-masculine environment
- Deeply rooted systemic racism, and anti-LGBTQIA discrimination
- Intensified power dynamics

What are specific challenges transgender women face during incarceration?



Transition Related Care

- Little access to information about transition-related care
- Difficulty accessing genderaffirming clothing and property
- Unable to access name and gender marker changes, often required to use legal name





Limited Medical Care

- Medical staff lack the knowledge and skills to meet the needs of transgender women
- Limited access to Hormone Replacement Therapy (HRT)
- Little to no access for gender-affirming surgeries
- Serious impacts when medical care is denied



Unsafe Housing in Detention

- Mostly based on sex assigned at birth
- Use of isolation and protective custody
- Transferring to women's facilities
 - CA SB132, WA DOC 490.700

POLICY

In partnership with the

California Department of

Corrections and Rehabilitation

- The Department has established procedures to ensure equitable treatment of transgender, intersex, and/or non-binary individuals when determining housing, classification, programming, and supervision.
- II. Drug testing will be completed per DOC 420.380 Drug/Alcohol Testing
- Searches will be conducted per DOC 420.310 Searches of Incarcerated Individuals. Individuals under community supervision will be searched per DOC 420.390 Arrest and Search.
- Gender-affirming basic state-issued items will be issued per DOC 440.050 State-Issued Items.

DIRECTIVE:

- Responsibilities
 - Appointing Authorities will ensure processes are in place for the management of transgender, intersex, and/or non-binary individuals.
 - B. All employees/contract staff/volunteers will address individuals by their preferred pronoun or their last name per DOC 100.500 Non-Discrimination for Individuals.
 - C. Incarcerated transgender, intersex, and/or non-binary individuals will receive medical/mental health care per the Washington DOC Health Plan and Guidelines for Healthcare of Transgender Individuals.
 - The Director of Prison Rape Elimination Act (PREA) Services will maintain a record in a secure imaging system of incarcerated individuals under the



Unsafe Access to Showers

- Often targeted for abuse and harassment in the shower
- Often not provided the option to shower separately
- Increases gender dysphoria





Dynamics of Sexual Abuse Experienced by Incarcerated Transgender Women



Dynamics of Sexual Harassment

- By staff and peers
- Ongoing anti-trans comments
- Misgendering
 - Name
 - Pronouns
- Hypersexualization





Dynamics of Sexual Abuse

- Coercion
- Protective Pairing
- Sex trafficking
- Corrective Rape
- Abusive and invasive searches





Sheila's Story

"Staff and officials here tell me: "You're not transgender you have a penis," and "This is a men's prison and you're going to be treated like a man."

Why might trans women survivors of sexual abuse in detention not report or seek help?



Barriers to Reporting

- Anti-LGBTQIA discrimination
- Fear of being charged with consensual sex
- Risk of retaliation
- Increased isolation of protective custody

Best Approaches for Supporting Incarcerated Trans Women Survivors





Getting Prepared

- Remember the dynamics of detention and sexual abuse
- Recognize how your identity may impact how you are perceived
- Be a resource for your agency to ensure a nuanced understanding and strategic approach



Tips for Providing Support


- Avoid making assumptions based on appearance or voice
- Always ask for a survivor's name and pronouns
- Discuss who the survivor is out to
- Allow for additional time for building rapport





Tips for Providing Support

- At forensic exams, be mindful of language about someone's body
- Know when to use a survivor's chosen name vs their legal name on letters
- Know the rights of trans survivors and be prepared to advocate on their behalf

Organizational Considerations

- Think about language used by your agency
 - Be clear and specify that your agency serves transgender people
- Partner with your local LGBTQIA+ organizations
- Learn about national, state and local laws that impact transgender people
